### Suggested wording for your beguest to Paralympics New Zealand

If you choose to make a bequest to Paralympics New Zealand in your will, the following wording is suggested. You can either include this wording in your will when it is drafted or, if you already have a will, you could include it in a codicil that supplements your will.

You will need to determine the details of your bequest to Paralympic New Zealand. For example, it could be a specified sum of money, or specified property or assets, or it could be all or a percentage of the residue of your estate.

# A. Suggested wording for making an unrestricted gift

"I give to PARALYMPICS NEW ZEALAND INCORPORATED (Charities Act registration no. CC33576, Incorporated Societies Act registration no. 220302), free of duty and transfer charges and to be used by Paralympics New Zealand Incorporated for its charitable purposes, [INSERT DESCRIPTION OF YOUR GIFT – FOR EXAMPLE: "the sum of \$\_\_\_\_\_\_", or "\_\_\_\_\_% of my estate", or "all of the residue of my estate", or "the following property/assets [insert description/list]"]. A receipt issued by Paralympics New Zealand Incorporated to my trustees for the gift shall be sufficient discharge to my trustees".

# B. Suggested wording for a restricted gift
